

Muhlenberg College 2023-24 Dependent Student Verification Worksheet

Your 2023-24 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before processing Federal Student Aid, the government may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information, the Office of Financial Aid will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit them to the Financial Aid Office.

Please provide the required information as quickly as possible because your financial aid cannot be finalized until verification has been completed.

- 1. **If requested**, please include any other requested tax documents such as W-2 forms or tax transcripts. Please note that a tax return (often the 1040) is not a tax transcript. Tax transcripts may be requested here: https://www.irs.gov/individuals/get-transcript
 - 2. Please write student's name on tax return transcript.
 - 3. Complete and sign this worksheet you and at least one parent must sign.
 - 4. Review all information sent from the Office of Financial Aid and the second page of this worksheet to see if you need to submit other documentation.

2023-24 Dependent Student Verification Instructions

For about half of our students, the U.S Department of Education requires schools to verify the data reported on the Free Application for Federal Student Aid (FAFSA). Your file has been selected for verification; please follow the steps as outlined below.

- 1. You must complete the 2023-24 Dependent Verification Worksheet. Remember to answer every question on the form; in addition, the form must be SIGNED by the student and at least one parent.
- 2. Both you and your parent(s) must provide official 2021 federal tax information. If you and/or your parents are not required to file a federal tax return per the IRS regulations, you will need to indicate this in Sections C and D on the 2023-2024 Dependent Verification Worksheet and submit W-2's and 1099-Misc. forms for 2021.
- 3. Additionally, parent nontax filers are required to provide an IRS Verification of Non-Filling Letter dated on or after October 1, 2021. The letter can be obtained by visiting www.irs.gov and typing in "Form 4506-T" in the search box. Once you have reached the form, fill out lines 1a through 5, check the box on line 7, type 12/31/2021 on line 9, then print and sign.
- 4. If you and/or your parents are required to file a federal tax return, you have two options (A and B listed below) in which to submit income information. Please make sure to indicate in Sections C and D on the 2023-2024 Dependent Verification Worksheet which option you choose.

A. IRS Data Retrieval Tool (HIGHLY RECOMMENDED FOR FASTER PROCESSING)

Most FAFSA filers have the option of securely transferring their 2021 income data directly from the Internal Revenue Service (IRS) database to their online 2023-2024 FAFSA. If you did not take advantage of this data transfer at the time you originally completed your FAFSA, you can still do so by going to www.fafsa.gov and updating your and your parents' tax infor mation reported on the FAFSA. You would need to select "Make FAFSA Corrections" and follow appropriate steps.

Applicants will need to authenticate their identity before any personal information is displayed. Once authenticated, you will be prompted to "transfer" the tax information to the FAFSA. You will need to complete this process for both you and your parents if a 2021 federal tax return is required to be filed with the IRS. You and your parents should not use the IRS Data Retrieval Process if any of the following situations apply:

Parents listed all zeros for Social Security Numbers on the FAFSA; Student or Parent used an 888 identifier in place of a Social Security Number on the FAFSA; Parent marital status date listed on the FAFSA is later than January 1, 2022; Student and/or parents have not yet filed or will not file a 2021 federal tax return; Parents have a tax filing status of "married filing separately for 2021

B. IRS Tax Return Transcript

If you and/or your parents are required to file a 2021 federal tax return and did not use the IRS Data Retrieval Process, you and/or your parents must request a 2021 Tax Return Transcript from the IRS and upon receipt, submit a copy to the Student Financial Aid Office. For parents who had a filing status of "married filing separately", IRS Tax Return Transcripts must be submitted for each parent. **PLEASE NOTE: IT MAY TAKE UP TO TWO WEEKS FOR THE IRS TO PROCESS YOUR REQUEST.** There are three methods to request a Tax Return Transcript:

- Via the IRS website at https://www.irs.gov/individuals/get-transcript, you can request one on-line;
- By calling 1-800-908-9946; or
- Complete and submit FORM 4506-T to the IRS.
- Please write the student's name on the transcript.
- 5. <u>Please submit in a timely fashion all documents at the same</u> time through your financial aid portal. Until all documents are received, the file cannot be reviewed.
- 6. Please review the instructions to make sure you have completed and submitted all the required documents. Failure to submit all the documents as per the instructions will delay processing your file.
- 7. If verification results in changes to your financial aid offer, we will update your financial aid portal and send you an email.

Verification of 2021 Income Information for Individuals with Unusual Circumstances

Individuals Who Filed an Amended IRS Income Tax Return

If an individual filed an amended IRS income tax return for tax year 2021, provide both of the following:

- A signed copy of the original 2021 IRS income tax return that was filed with the IRS or a 2021 IRS Tax Return Transcript for the 2021 tax year.
- A signed copy of the 2021 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS.

Individuals Who Were Victims of IRS Identity Theft

A victim of IRS identity theft who is not able to obtain a **2021 IRS Tax Return Transcript** or use the IRS DRT must contact the IRS at 1-800-908-4490. Upon authentication of the tax filer's identity, the IRS will provide, by U.S. Postal Service, a printout of the tax filer's 2021 IRS income tax return information.

Individuals Who Filed Non-IRS Income Tax Returns

• An individual filed or will file a 2021 income tax return with Puerto Rico, another U.S. territory (e.g., Guam, American Samoa, the U.S. Virgin Islands, the Northern Marianas Islands), or with a foreign country, must provide a signed copy of that 2021 income tax return(s).
